FYI:

Regarding tentative 2018-2019 permit, the 2018 proposed rules by city DPR and bodysurfing access at pipeline:

We had offered to withdraw our conflicting application back in November 2017 [during city permit mediation period] if the Da Hui Backdoor Shootout would agree to allow at least half of their 30 bodysurfers as open entries and NOT invitees. [see email dated 11/2/2017 below].

Below you can see the revised agreement sent back to Stacy Moniz and Mahina of Da Hui with the corrections he requested - [dated May 5, 2018; below this email]. Since we made the changes requested by Moniz, they apparently have not moved forward with that agreement.

Recently, we received opinions by experts that the city DPR permit application and its supplement documents are a contract between the city and the applicant; therefore we believe the current Da Hui Backdoor Shootout application supplement is a commitment to run **30 bodysurfers, as well as 30 bodyboarders and 30 stand-up paddleboard surfers** in the event.

Therefore, it is unnecessary to have the Da Hui Back Door Shootout enter into a separate agreement to run 24 competitors. [See Attached: Application supplement] - pdf

As a result of this conclusion, we will release the permit hours for this season [2018-2019] next week.

Additionally, On Saturday June 2, 2018 The city announced a New Rule making hearing on July 3, 2018. see press release at bottom of this email & Attached: PR].

Upon initial review of the Proposed Rules Draft, it eliminates the mediation process and the appeal process; it does not change [repair] the non-functional conflict resolution process and it expands permit control for 3 years at a time. The city rule drafting personnel need to learn about how to create a process that works for the purpose of conflict resolution so that a fully diverse and appropriate grouping of wave-riding events will prevail.

Moving forward, we are hoping that the City Dept. of Parks & Recreation will make the effort to create a more effective set of rules which cherish the North Shore surf as a resource and compel ALL event directors [permit recipients] to run events efficiently [i.e. with a minimum of 40 competitors per competition day or a minimum of 5 competitors / hour] and a MAXIMUM of 3 competition days attached to one event permit.

Hopefully, with an abundance of testimony, eventually the city will allow a few more historically significant and diverse events to remain on the City Dept. of Parks & Recreation North Shore Surf event calendar.

We believe that this can be achieved without the necessity or possibility of allowing more competition days on the City Dept. of Parks & Recreation North Shore Surf event calendar.

Please note the amount of hours run on the 2017-2018 North Shore surf season calendar 375 hours of short board surfing, 7.5 hours of bodysurfing and 0 hours of bodyboarding. see attached.

Draft Agreement TEXT:

This Agreement made as of _____, 2018 by and between PIPELINE WORLD GAMES, INC., NORTH SHORE BODYSURFING CLUB and HUI O HE'E NALU INC., (collectively, the "Parties") for the 2018-2019 DA HUI BACKDOOR SHOOTOUT to run approximately 3.5 hours of bodysurfing as a division of the event.

The Parties agree that the 2018-2019 DA HUI BACKDOOR SHOOTOUT will run a division of bodysurfing competition **consisting of approximately** 24 competitors in the 2018-2019 BACKDOOR SHOOTOUT event (the "Event"). This division would take approximately 3.5 hours including a final heat.

The Parties agree that, PIPELINE WORLD GAMES, INC, NORTH SHORE BODYSURFING CLUB, will, **upon execution of this Agreement by the parties herein, immediately** rescind/**withdraw i**ts application to the City & County of Honolulu Department of Parks and Recreation (the "Department") for a 2018-2019 holding period in conflict with the holding period in the application filed with the Department by HUI O HE'E NALU INC.
